STATE OF THE SCHOOL

ACCREDITATION

Notre Dame Academy is dually accredited by both the Minnesota Nonpublic Schools Association (MNSAA) and Lumen. These organizations ensure NDA upholds a rigorous, nurturing and virtuous experience for our community.

We completed several items on our MNSAA School Strategic Plan including: completing a long term technology plan to track standards completed in all core subjects, and implementation of a new Behavior Management Plan.

BELIEVE AND READ RESULTS

Our Groves reading program is a research and phonetics-based system that has shown great results in introducing effective literacy techniques to our young readers.

We are closing the gap from below grade level to grade level/above. Students receive multiple levels of intervention, from whole group, small groups, and intensive intervention for those who need it.

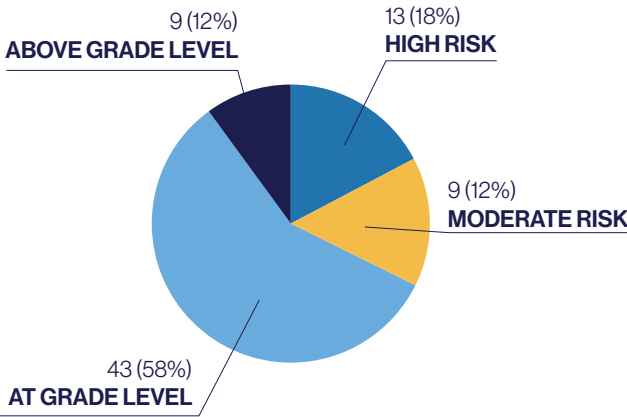
Next we look forward to working on: Creating a Volunteer orientation, completing a Comprehensive Security/Continuity plan per Homeland Security as well as creating a Development Plan and new Development database system.

We completed the onsite visit in April to become accredited by Lumen. We now look forward to working on a roadmap that will guide important initiatives over the next few years. Notre Dame Academy will focus on our Catholic identity as a staff as well as our mission as a Catholic school.

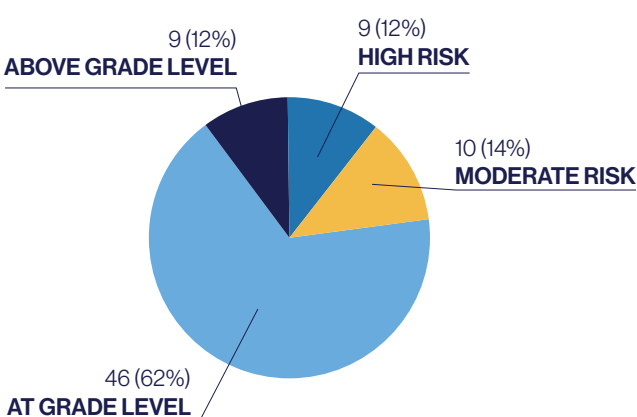

SPRING 2025 RISK CATEGORY



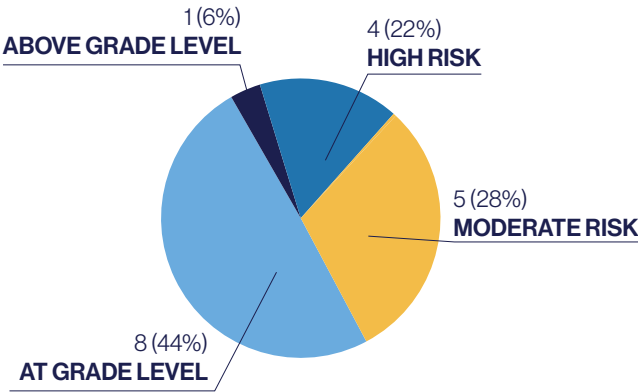
MAP TEST DATA

Each year NDA students in grades 1-8 take the MAP assessment three times a year to track their growth and allow faculty to see valuable information on student skills teachers can then differentiate and individualize learning for students. Grades 1-2 take an auditory assessment in reading and math. This

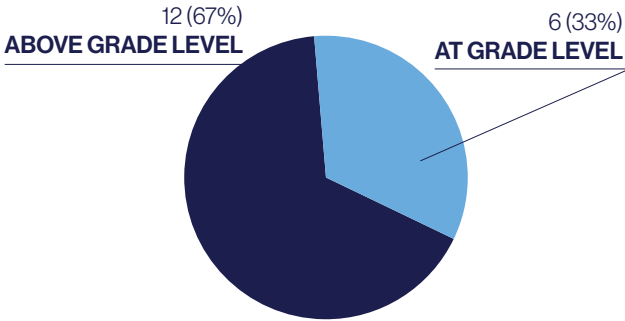
assessment is one snapshot in time but also provides valuable data. Grades 3-5 take reading, math, and language arts assessments and grades 6-8 also add science. The data shows that our students consistently outperform national norms.

SPRING 2025 RISK CATEGORY



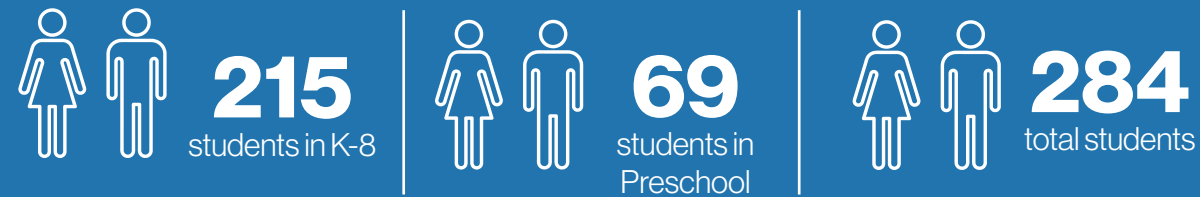

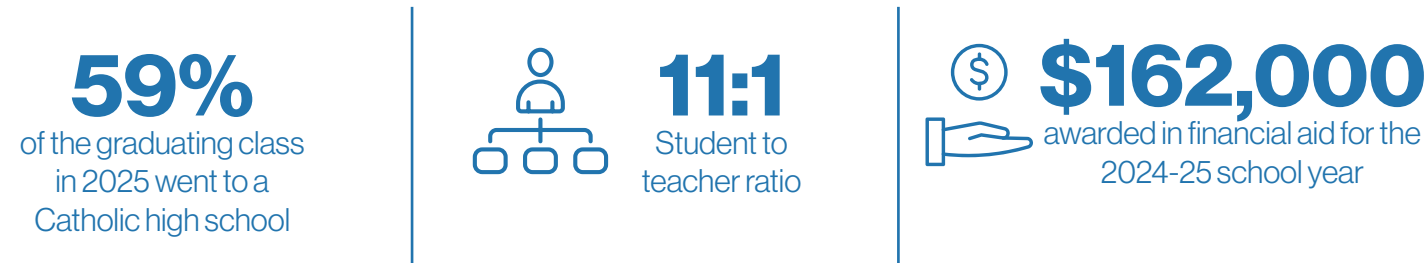
ENROLLMENT FOR 2024-25 SCHOOL YEAR

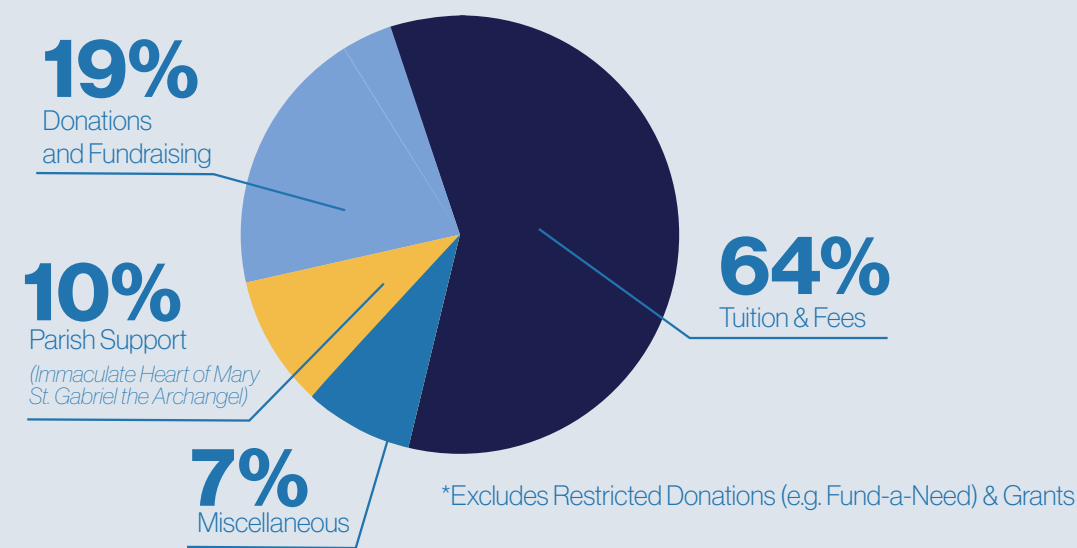

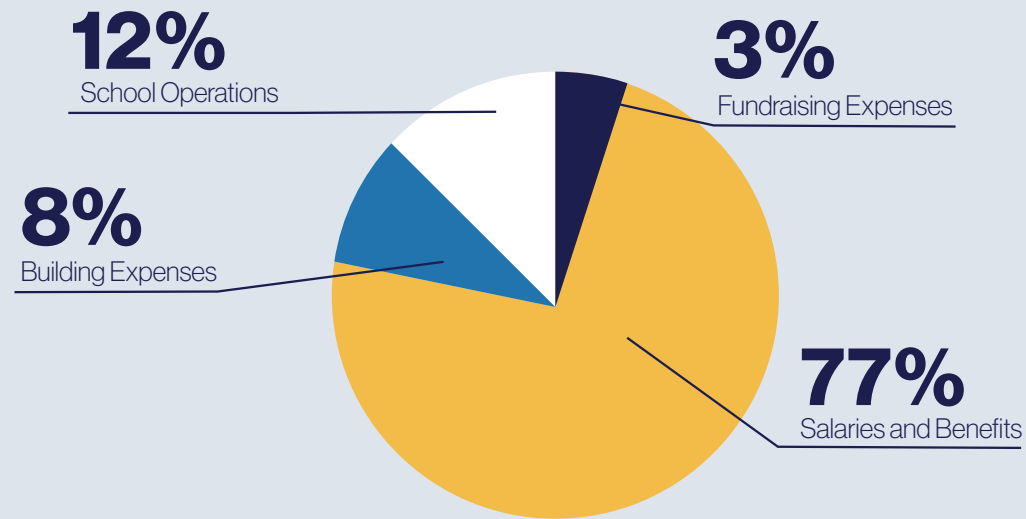

2024-25 SCHOOL INCOME – \$2.38 M



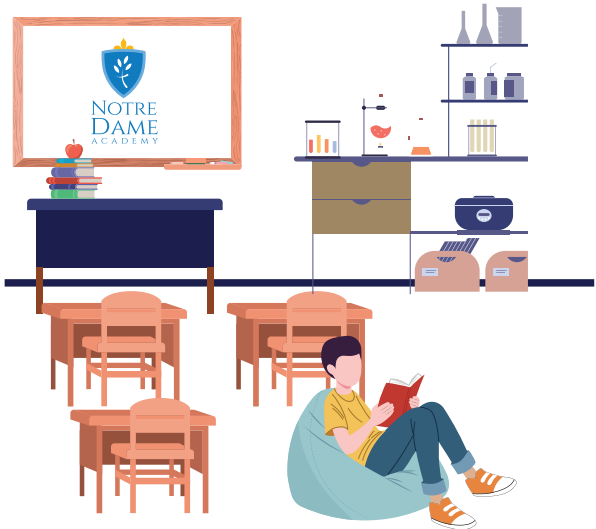
2024-25 OPERATING EXPENSES – \$2.24 M

NEW FOB ENTRY SYSTEM AND BUILDING PAINT REFRESH

We installed a new security fob system that allows greater control of the entrances. The entire school was painted including hallways, classrooms and the cafeteria, giving everything a fresh, clean look.
